1. GENERAL INFORMATION, FUNDAMENTAL PRINCIPLES AND RULES

- 1.1. Atatürk University Foreign Student Exam (International Student Exam) ATAYÖS is an exam that can be applied by foreign students who wish to study at Atatürk University, undergraduate and undergraduate degree, in formal and open education programs, while applying process they can use these exam results.
- 1.2. This guide includes the exam process and the provisions for those who want to apply to ATAYÖS in order to study at Ataturk University's undergraduate or undergraduate programs for the 2023-2024 academic year.
- 1.3. **ATAYÖS-2023 will be held in all examination centers at the same time (Turkish time) on Saturday, June 10, 2023 at 11:00.**
- 1.4. **CLICK** for Application Calendar.
- 1.5. The results of ATAYÖS-2023 are valid for 1 (one) year and can only be used for 2023-2024 academic year associate degree program and undergraduate applications.
- 1.6. Turkish and English are the languages (e-mail, mail, fax, telephone calls, etc.) in communication with the candidates who will attend ATAYÖS-2023.
- 1.7. The rules in this guide can be changed if the legislative, executive and judicial organs and the Higher Education Council and Evaluation Board, Atatürk University Administrative Board and Atatürk University Senate Decisions, which can take effect after the publication date, are required. In this case, the path to be followed is determined by Atatürk University. For cases not specified in this guide, action is taken according to the decisions made by Atatürk University.
- 1.8. ATAYÖS guide will be published on the official website of our university on the link <http://admission.atauni.edu.tr/atayos/> and it will not be printed and distributed again.

2. APPLICATION CONDITIONS

- 2.1. Applications for the exam both in Turkey and abroad will be made on <http://yosbasvuru.atauni.edu.tr/>. Applications not made within the application period will not be accepted.
- 2.2. It is obligatory to have the conditions given in 2.3 in order to register to a program after the placement made according to ATAYÖS exam results. Candidates who cannot submit their documents during registration period are not registered at the university.
- 2.3. Candidates who will apply;
 - a) Provided that they are in the last year of high school or graduated;
 - 1) Those who are foreign,
 - 2) Those who have Turkish citizenship by birth and who have been granted permission from the Ministry of Internal Affairs to get out of Turkish citizenship and who document that they have a document regarding the exercise of the Recognized Rights obtained under the Turkish Citizenship Law in Article 7 of the Turkish Citizenship Law (5901). (1) in Turkey or abroad Turkish citizens a child born Turkish citizen of wedlock is a mother or father. "Judgment is located in, candidates will apply for abroad acceptance quota is beneficial in the Turkish Citizenship Law review.
 - 3) Those who became Turkish citizenship with foreign citizenship and foreign citizenship / dual citizens in this situation.
 - a) Among the students who have completed secondary education abroad (high school) in a foreign country other than Turkish Republic of Northern Cyprus/TRNC (including those who have completed all of their secondary education (high school) in Turkish schools outside of TRNC) before 01 February 2013, be able to apply for student acceptance quotas from abroad
 - b) Candidates who have completed secondary education (high school) in a foreign country other than TRNC (including those who have completed all of their secondary education (high school) in a foreign country other than TRNC), for candidates who started secondary education abroad after 01/02/2013, can apply.
 - 4) Applications are accepted for those who have resident in TRNC and have completed their secondary education (high school) in TRNC and who have or will have GCE AL exam results by enrolling in and training in colleges and high schools between 2005-2010.
 - b) The candidates
 - 1) those who are Turkish citizens who completed secondary education (high school) of all in Turkey or the TRNC,

- 2) T.R.N.C. nationals (except those who have completed their entire secondary education (high school) in T.R.N.C high schools and have GCE AL results, and who have or will have GCE AL exam results by enrolling in and training in colleges and high schools in other countries between 2005-2010)
- 3) Republic of Turkey's dual nationals whose first nationality of birth defined in item 2 as Turkish Republic, (except those who meet the conditions in item 4, item a)
- 4) One of the nationality is T.R.N.C. dual citizens (except those who have completed their secondary education (high school) in TRNC high schools and have GCE AL results and those who have or will have GCE AL exam results by enrolling in and training in colleges and high schools in other countries between 2005-2010),
- 5) those receiving education at schools affiliated to embassies in Turkey, citizens of Republic of Turkey who get their education at foreign schools in Turkey or that an issue number 2 of subparagraph defined by birth first nationality Republic of Turkey with dual nationality, are not accepted.

3.2. Depending on the ÖSYM (Student Selection and Placement Centre) exam/registration dates, the rectorate may update the placement calendar.

4. APPLICATION PROCEDURES

- 4.1. All applications made domestically and abroad will only be made on the internet address <http://yosbasvuru.atauni.edu.tr/>. Applications that are not made through the internet address above between **April 3rd, 2023 and May 15th, 2023**, via hand or via mail will not be accepted.
- 4.2. Candidates will enter the system online (<http://yosbasvuru.atauni.edu.tr/>) within the application period, read the explanations carefully and make their registration to the system.
- 4.3. All responsibility belongs to the candidates for the consequences resulting from the deficiencies and errors in the information given to the system during registration. The identity information fields of the system must be entered without changing the candidate's official identity information and without shortening. After registering to the system, no editing can be made on personal information.
- 4.4. The e-mail and phone number requested when registering in the system must belong to the candidate and each candidate must use only one e-mail. No correspondence or transaction should be made on behalf of other candidates via this e-mail and phone number.
- 4.5. The passport photo of the candidate taken in the last three months scanned in the format of (.JPG) or (.PNG) or (.PDF) and that does not exceed 1MB should be uploaded to the registration page in the system. Photographs should be able to be used in passports or other official identity documents. The photos uploaded by the candidates will also be placed on the Exam Entry Document and Exam Result Document. If the examiners have difficulty determining the identity of the candidate from the photograph in the Exam Entrance Document, it should be taken into consideration that the candidate will not be taken to the exam.
- 4.6. A verification link and Candidate Number will be sent to the email address entered in the system. Candidates are required to enter the system by clicking on the link sent and activate their page.
- 4.7. After activating the account, you can enter the username and password and select the ATAYÖS-2023 APPLICATION link and make the final exam application. ATAYÖS-2023 application will be completed after the examination fee has been paid and after the application procedures have been checked and approved by the advisors. Candidates who will apply to ATAYÖS will pay the exam fee according to the information specified in the 5th EXAM FEE section below.
- 4.8. Applicants will be given the Candidate number only once. It is mandatory to indicate the candidate number in all correspondence with Atatürk University.

5. EXAM FEE

5.1. Candidates will be charged for the exam according to the table below.

5.2 Exam fees taken from candidates are not transferred to the next years. The fees of the applicants who give up the application even though they have paid the fee, whose application is invalid, do not enter/enter the exam, are not taken to the exam, taken out of the exam, who fail in the exam, and whose exam is invalid are not reimbursed. If it is determined that the candidates make payments from both accounts by creating different accounts in the system, the fee paid is not refunded. The application of the candidate who does not pay the exam fee is not accepted.

5.3 Only if the exam to be held by Ataturk University in the exam center chosen by the candidate is cancelled, the exam fee will be refunded. Except for this, no exam fee is refunded. Since refunds are made in TL (Turkish Lira), they are returned according to the current exchange rate.

5.4 Exam fee can be paid in two ways:

- a. Exam fee can be deposited online via the system. For this, candidates must have credit cards or debit cards (Visa or MasterCard) that can be paid online. In the online payment, the application is automatically approved if the payment made. The confirmation message will come to the e-mail address you entered during the registration to the system.
- b. Exam fee can be paid as EFT / Money Order / SWIFT. Candidates who will apply for the exam from abroad and domestically will be able to pay the exam fee through a correspondent bank or international banks.

5.5 The points to be paid attention by the candidates who will pay exam fees from domestic and abroad are listed below.

- Write your Candidate Number your name and surname as stated in your foreign identity in the explanation section.
- When depositing the exam fees, the amount that the banks will receive the transfer transaction fee should be calculated outside the amount to be paid as the exam fee.
- Candidates who pay the exam fee should check the bank receipt given to them carefully before leaving the bank, and if there is a mistake in their information, they must correct them without leaving the bank.
- After paying the exam fee, enter the system and upload the picture of your bank receipt and the page of your passport with the identity information or your TR identity document. Your application will be invalid if the receipt you uploaded to the system is unreadable or if another image has been uploaded.
- The money sent by the candidates is considered to be deposited after they are transferred and transferred to the account. Exam fee must be taken into account completely within the application schedule. Otherwise, money taken into account outside the schedule will not be refunded and the application will be invalid.
- Special checks, money, postal checks and similar items must not be sent for Exam Application fee.
- If the above-mentioned information is missing or incorrectly entered (loading the receipt in an unreadable manner), the application will be invalid and your money will not be refunded.

6. EXAM CENTERS

6.1. ATAYÖS-2023 will be held at the following exam centers:

Turkey: Ankara, Antalya, Bursa, Erzurum, Gaziantep, Hatay, İstanbul-Anatolia, İstanbul-Europe, İzmir, Kilis, Konya, Mersin, Samsun, Şanlıurfa, Van

Germany: Dortmund, Iran: Tehran, Tabriz, Turkish Republic of Northern Cyprus: Nicosia, Saudi Arabia: Jeddah

Azerbaijan: Baku, Bosnia and Herzegovina: Sarajevo, Egypt: Cairo, Georgia: Tbilisi, Indonesia: Jakarta, Iraq: Mosul, Jordan: Amman, Kazakhstan: Almaty, Kosovo: Pristina, Kyrgyzstan: Bishkek, Lebanon: Beirut, Macedonia: Skopje, Malaysia: Kuala Lumpur, Morocco: Rabat, Romania: Bucharest, Uzbekistan: Tashkent, Sudan: Khartoum.

6.2. During the application, candidates are asked to choose 1 (one) “examination center preference”. Exam language preference will be required together with the exam center. The exam centers and exam language you prefer are not changed after payment.

6.3. The exam booklet will be in two languages: Turkish (in all booklets) and in the "support language" you choose from the list (Turkish - English, Turkish - French, Turkish - Arabic, Turkish - Persian, Turkish - Russian, Turkish -Azerbaijani). Candidates can only choose 1 (one) exam “support language” during the application. The original text is Turkish, the "support language" you choose will be given to help you for understanding the questions.

6.4. Ataturk University reserves the right to change and cancel the exam centers until 10 days before the exam date. For this reason, you need to login to the system 10 days before the exam and check your exam preferences.

7. EXAM INFORMATION

- 7.1** A total of 80 questions will be asked under the heading Basic Learning Skills. The exam will be evaluated on the scale of 100 points. The answering time given in this exam is 150 minutes (2.5 hours).
- 7.2** Students placed in the program are taken to the Turkish and Foreign Language Proficiency Exam to be held by the relevant units of the university. Students who succeed in these exams start their education directly from the first year without having to study Turkish and Foreign Language preparatory class, and students who do not succeed receive preparatory class training.
- 7.3** ATAYÖS and related transactions will be carried out depending on the exam schedule.
- 7.4** The Rules to be followed in the Exam are as follows:
- a. It is strictly forbidden to take the exam with a mobile phone. It is also forbidden to take the exam with pager, radio, etc. communication devices and pocket computer, clock with function other than clock function, etc. all kinds of computer-capable devices, as well as weapons, etc. electronic equipment, calculator, scratch sheet, compasses, protractor, ruler etc. with equipment, notebook, book, dictionary, dictionary functioning electronic device. The foreign national numbers of the candidates who have taken the exam with these tools must be written in the Hall Exam Minutes and the exams of these candidates will be deemed invalid.
 - b. The answering time given in this exam is 150 minutes (2.5 hours).
 - c. The candidate who leaves the hall by submitting the exam documents will not be taken back to the exam for any reason whatsoever.
 - d. No candidate will be allowed to go out during the first 75 and the last 10 minutes of the exam.
 - e. If you complete the answering process after the first 75 minutes and before the last 10 minutes, you can leave the hall by handing your answer sheet, question booklet and ATAYÖS Exam Entry and Identification Document to the salon officials. Otherwise, you must stay in your places until the announcement of the exam period is over and wait for all the answer sheets and question booklets to be collected.
 - f. It is forbidden to talk and ask questions to the invigilators during the exam. Likewise, it is forbidden for the invigilators to talk to the candidates closely and in a low voice. In addition, candidates cannot exchange a pen, eraser, etc. among themselves.
 - g. During the exam, you have to comply with all warnings of the invigilators. When necessary, invigilators can change your places. Validity of your exam depends first of all on whether you obey the rules of the exam. If you act against the rules and do not comply with the warnings to be made, your identity will be written in the report and your exam will be invalid.
 - h. Those who cheat, attempt to cheat, copy, and help with cheating during the exam will be written in the Hall Exam Minutes and their exams will be invalid. Invigilators don't have to warn those who attempt to cheat. Responsibility belongs to the candidate. It is extremely important for you to keep your answer sheet invisible to others during the exam. The distribution of the answers given by the candidates to the questions will be examined with information processing methods. If the findings obtained from these reviews indicate that any kind of cheating was attempted individually or collectively, some or all of the answers of the candidates participating in the cheating act will be cancelled. If the exam invigilators report that the exam is not carried out in accordance with the rules and that a mass cheating attempt takes place in a hall, Atatürk University can use the discretion to override the exam of all candidates who take the exam in this hall.
 - i. You must fill in the relevant fields on the answer sheet. A pencil will be used in all kinds of writing and all markings to be written on the answer sheet. Ballpoint pen and fountain pen will never be used. Answers must be marked on the answer sheet. Answers marked in the question booklet are not valid.
 - j. As soon as you receive your question booklet, check if the pages are missing and if there are any printing errors in the booklet. If the page of your question booklet is incomplete or incorrect in printing, contact the Hall Chair immediately. Check if the type of question booklet printed on each page of the question booklet is the same as the question booklet type printed on the front cover of the booklet. If it is different, ask the Hall Chair for a new question booklet. If you later notice that the type of your question booklet is different, contact the Hall Chair to give you an error-free question booklet of the type you have answered so far. Do not forget to mark the type of question booklet

that will be given to you on your answer sheet. If this sign is not included, your exam will be considered invalid because it is not possible to evaluate your exam.

- k. Please write your name, surname, application number and the hall number of this hall to the place reserved on the question booklet to be given to you before answering. At the end of the exam, question booklets will be collected and examined one by one at Atatürk University. If a single page of the exam booklet is missing, your exam will be invalid.
- l. You can use blank places on the pages of the question booklet for draft.
- m. During the exam, no one, including invigilators, will not smoke, cigarette, pipe, cigar, etc.
- n. It is strictly forbidden to write the questions and the answers you give to these questions on a separate piece of paper and take it out.
- o. Before leaving the exam room, do not forget to hand over your question booklet, answer sheet and ATAYÖS Exam Entry and Identification Document to the invigilators.

8. EXAM OBJECTION TIME

- 8.1 The exam questions and the exam results are officially given a 3-day reclamation period. Appeals must be accepted through the official e-mail address of the ATAYÖS exam in the form of a petition between the dates specified in the table. Objection must be accepted through the official e-mail address of the ATAYÖS exam in the form of a petition between the dates specified in the table. In addition, the exam objection petitions must be sent to the office address specified on our page within 10 days by mail.
- 8.2 The Question Objection Commission decide on objections. The results are sent to the candidates via the e-mail address specified in the system.

9. PREFERENCE PROCEDURES

- 9.1 Preference transactions will be made at <http://yosbasvuru.atauni.edu.tr/>
- 9.2 Candidates who get at least 30 points from ATAYÖS exam can choose the program.
- 9.3 A total of 15 choices are taken from candidates, with a maximum of 5 for formal education programs and 10 for ATA-OEF (Atatürk University Open Education) programs.
- 9.4 After the placements made according to ATAYÖS score, placement can be made according to the high school graduation score for vacant quotas of the Open Education Faculty.
- 9.5 For students who want to choose programs that accept students with a special aptitude test:
With the condition that they get at least 40 points from ATAYÖS exam, students who will apply for the programs which take students with the Special Aptitude Exam must take the special talent exam to be held by the relevant unit without making a choice over the system and they must be successful in this exam.
- 9.6 Scores of candidates from these exams can be used by many other universities in Turkey, particularly Universities which are UNIP members. **CLICK** to see the universities that accept ATAYÖS-2023 exam results.

10. FIRST PLACEMENT

- 10.1. First placement period is the period which candidates who want to study at the undergraduate and associate degree levels at Atatürk University can apply only with their ATAYÖS 2023 and TR-YÖS 2023 exam results.
- 10.2. The "Turkish Foreign Student Admission Exam (TR-YÖS)", which will be held by ÖSYM to be implemented as of 2023, will be used in the acceptance of international students as equivalent to the Atatürk University International Student Admission Exam (ATAYÖS) which is organized by our university.

11. ADDITIONAL PLACEMENT

- 11.1. The first additional placement period is for the candidates who want to study at the undergraduate and associate degree levels at Atatürk University. In addition to the ATAYÖS 2023 and TR-YÖS 2023 exams accepted in the first placement period, as well as the international exam results announced to be

accepted by Atatürk University and other state universities' YÖS results who share their statistical information.

11.2. In the first additional placement period, the exam scores of the candidates who will apply with exams other than ATAYÖS 2023 and TR-YÖS 2023 will be multiplied by 0.9 before consideration.

11.3. Candidates who are eligible to apply for the first placement must comply with the following criteria:

- Student candidates who participated in the ATAYÖS 2023 and TR-YÖS 2023 exams, who choose a program in Atatürk University but did not get placed,
- Student candidates who take the exams of other Higher Education Institutions, whose exam results are stated on the Atatürk University website where they are accepted.

11.4. Second Additional placement period is for the candidates who want to study at the undergraduate and associate degree level at Atatürk University. In addition to ATAYÖS 2023, TR-YÖS 2023, international exams announced to be accepted by Atatürk University and other state universities' YÖS results who share their statistical information and held their exams face to face, also with diploma scores approved by the Council of Higher Education.

11.5. In the second additional placement period, all exam scores will be considered as equivalent and evaluated.

11.6 CLICK for the list of international exams accepted by Atatürk University for additional placement applications.

11.7 Applications for the exam both in Turkey and abroad will be made at <http://yosbasvuru.atauni.edu.tr/>. Applications not made within the application period will not be accepted.

11.8 Student candidates who take the exams of other Higher Education Institutions in accordance with the document verification criteria given below will be accepted by multiplying the exam results by 0.9.

- a) Those who do not upload the part with the Verification Link and Verification Code to the system;
- b) Those who do not have the Verification Link and Code in document;
- c) Those who uploaded the YÖS Exam Result of the previous year not specifying the exam date and validity period
- d) Documents which have incompatibility between the information entered manually in the system and the information in the uploaded document (Example: 95,342 (The number of exam results in documents will be entered as 3 digits after the comma) will be invalid and the applications of the candidates with such documents will not be evaluated.

12. REGISTRATION INFORMATION

12.1 According to the results of the evaluation, students who have the right to enroll in the University must register with the necessary documents between the dates determined by the Registrar's Office on the official website. Candidates who do not register within the deadline are deemed to have lost their right to register. In order to register, the following documents must be provided:

For Those Residing Abroad:

- Original high school diploma
- Certified Turkish translation of high school diploma by Turkish Foreign Representatives
- Diploma Equivalency Certificate (it can be obtained from Turkish Foreign Representatives in your countries)
- Original Transcript
- Transcript: Certified Turkish translation by Turkish Foreign Representatives
- ATAYÖS Result Document (Candidates who do not take ATAYÖS exam in the ADDITIONAL PLACEMENT period registrations should bring the original document they used when applying.)
- Placement Result Document
- In the additional placements, there must be the original and a Turkish translation approved by the Turkish Foreign Representatives of the document uploaded to the system. (With the GCEAL exam results of those who completed high school in TRNC)
- 2 Passport Photos
- Approved copy of the passport and passport and certified copy of the passport from Turkish Foreign Representatives translated into Turkish.

- Receipt of permission of the blue card holders with blue card to leave Turkish citizenship from the Ministry of Internal Affairs.
- Written declaration stating that they are financially able to cover their expenses during the education period in our country (excluding Turkish students)
- Bank receipt showing that the contribution fee has been deposited (During the registration, it is deposited in one of the banks that our University has an agreement with the number given after the Pre-Registration by the International Students Office of the Student Affairs Office.)
- Turkish Proficiency Certificate (Candidates who cannot submit this document will be taken to the Turkish Placement Exam held by our University.)
- Certificate of identity register copy (Dual nationals)

For Those Living in Turkey:

- Original High School Diploma
- Notarized Turkish translation of High School Diploma in Turkey
- Diploma Equivalency Certificate (it can be taken from Provincial Directorate of National Education)
- Original Transcript
- Notarized Turkish translation of transcript in Turkey
- ATAYÖS Result Document (Candidates who do not take the ATAYÖS exam in the ADDITIONAL PLACEMENT period must bring the original document they used when applying.)
- Placement Result Document
- In the additional placements, there must be the original and a Turkish translation approved by the Turkish Foreign Representatives of the document uploaded to the system. (With the GCEAL exam results of those who completed high school in TRNC)
- 2 Passport Photos
- Passport, certified copy of passport and a notarized copy of passport translated in Turkish in Turkey.
- Receipt of permission of the blue card holders with blue card to leave Turkish citizenship from the Ministry of Internal Affairs.
- Written declaration stating that they are financially able to cover their expenses during the education period in our country (excluding Turkish students)
- Bank receipt showing that the contribution fee has been deposited (During the registration, it is deposited in one of the banks that our University has an agreement with the number given after the Pre-Registration by the International Students Office of the Student Affairs Office.)
- Turkish Proficiency Certificate (Candidates who cannot submit this document will be taken to the Turkish Placement Exam held by our University.)
- Certificate of identity register copy (Dual nationals)

12.2 Registration is cancelled for those who are falsified during the application, placement and registration process, and for those who provide false, incomplete and incorrect information even if they are registered with final enrolment.

12.3 Candidates who are entitled to final registration can only register for the program in the Placement Result Document.

12.4 Placement Result Document replaces acceptance letter.
