1. GENERAL INFORMATION, FUNDEMENTAL PRINCIPLES AND RULES

1.1. This guide covers the application process and the provisions to be applied for candidates who wish to study in associate degree or undergraduate programs of Atatürk University for the 2025-2026 Academic Year.

1.2. Turkish and English will be used as the language of communication (e-mail, mail, fax, telephone calls, etc.) with the candidates who will apply to Atatürk University.

1.3. This guide will be published on the official website of our university at <https://admission.atauni.edu.tr> and will not be printed and distributed separately

1.4. The rules in this guide may be amended if required by the legislative, executive and judicial bodies that may enter into force after the publication date of the guide and the decisions of the Presidency of the Council of Higher Education, Atatürk University Senate or Board of Directors. In this case, the path to be followed is determined by Atatürk University.

1.5. For situations not specified in this guide, action is taken according to the decisions made by Atatürk University.

2. APPLICATION CONDITIONS

2.1. Applications to Atatürk University both in Turkey and abroad will be made on <http://yosbasvuru.atauni.edu.tr/>. Applications not made within the application period will not be accepted.

2.2 In order to enroll in a program after the placement, it is mandatory to have the conditions given in 2.3. Candidates who cannot submit their documents during registration will not be enrolled in the university.

2.3. Candidates who will apply;

- a) Provided that they are in the last year of high school or graduated;
 - 1) Those who are foreign,
 - 2) Those who have Turkish citizenship by birth and who have been granted permission from the Ministry of Internal Affairs to get out of Turkish citizenship and who document that they have a document regarding the exercise of the Recognized Rights obtained under the Turkish Citizenship Law in Article 7 of the Turkish Citizenship Law (5901). (1) in Turkey or abroad Turkish citizens a child born Turkish citizen of wedlock is a mother or father. "Judgment is located in, candidates will apply for abroad acceptance quota is beneficial in the Turkish Citizenship Law review.
 - 3) Those who became Turkish citizenship with foreign citizenship and foreign citizenship / dual citizens in this situation.
 - a) Among the students who have completed secondary education abroad (high school) in a foreign country other than Turkish Republic of Northern Cyprus/TRNC (including those who have completed all of their secondary education (high school) in Turkish schools outside of TRNC) before 01 February 2013, be able to apply for student acceptance quotas from abroad
 - b) Candidates who have completed secondary education (high school) in a foreign country other than TRNC (including those who have completed all of their secondary education (high school) in a foreign country other than TRNC), for candidates who started secondary education abroad after 01/02/2013, can apply.
 - 4) Applications are accepted for those who have resident in TRNC and have completed their secondary education (high school) in TRNC and who have or will have GCE AL exam results by enrolling in and training in colleges and high schools between 2005-2010.
- b) The candidates
 - 1) those who are Turkish citizens who completed secondary education (high school) of all in Turkey or the TRNC,
 - 2) T.R.N.C. nationals (except those who have completed their entire secondary education (high school) in T.R.N.C high schools and have GCE AL results, and who have or will have GCE AL exam results by enrolling in and training in colleges and high schools in other countries between 2005-2010)

- 3) Republic of Turkey's dual nationals whose first nationality of birth defined in item 2 as Turkish Republic, (except those who meet the conditions in item 4, item a)
- 4) One of the nationality is T.R.N.C. dual citizens (except those who have completed their secondary education (high school) in TRNC high schools and have GCE AL results and those who have or will have GCE AL exam results by enrolling in and training in colleges and high schools in other countries between 2005-2010),
- 5) those receiving education at schools affiliated to embassies in Turkey, citizens of Republic of Turkey who get their education at foreign schools in Turkey or that an issue number 2 of subparagraph defined by birth first nationality Republic of Turkey with dual nationality, are not accepted.

3.2. Depending on the ÖSYM (Student Selection and Placement Centre) exam/registration dates, the rectorate may update the placement calendar.

4. APPLICATION PROCEDURES

- 4.1. All applications made domestically and abroad will only be made on the internet address <http://yosbasvuru.atauni.edu.tr/>. Applications that are not made through the internet address above between the dates mentioned above, via hand or via mail will not be accepted.
- 4.2. Candidates will enter the system online (<http://yosbasvuru.atauni.edu.tr/>) within the application period, read the explanations carefully and make their registration to the system.
- 4.3. All responsibility belongs to the candidates for the consequences resulting from the deficiencies and errors in the information given to the system during registration. The identity information fields of the system

must be entered without changing the candidate's official identity information and without shortening. After registering to the system, no editing can be made on personal information.

- 4.4.** The e-mail and phone number requested when registering in the system must belong to the candidate and each candidate must use only one e-mail. No correspondence or transaction should be made on behalf of other candidates via this e-mail and phone number.
- 4.5.** A passport size photograph of the candidate taken within the last three months must be scanned in (.JPG) or (.PNG) or (.PDF) format and uploaded to the registration page in a format not exceeding 1MB. The photographs must be of a quality that can be used in passports or other official identity documents.
- 4.6.** A verification link and Candidate Number will be sent to the e-mail address entered in the system. Candidates must enter the system by clicking on the link sent and activate the page.
- 4.7.** After the account is activated, the application can be made by entering the username and password. The application will be considered complete after the application fee has been paid and the application process has been checked and approved by the relevant persons. Candidates will pay the application fee within the application period according to the information specified in the 5th APPLICATION FEE section below.
- 4.8.** Candidate number will be given to the applicants only once. It is mandatory to specify the candidate number in all correspondence with Atatürk University.

5. APPLICATION FEE

- 5.1.** A fee of 1500 TL will be charged for the application. Each candidate will pay the application fee only once for all application periods.
- 5.2.** The application fee received from the candidates is not transferred to the following years. No refund will be made for candidates who have paid the application fee but withdraw their application or whose application is deemed invalid. In case it is determined that candidates create different accounts in the system and pay from two accounts, the fee paid will not be refunded. The application of the candidate who has not paid the fee will not be accepted.
- 5.3.** The application fee can be paid online through the system. For this purpose, candidates must have a credit card or a debit card (Visa or MasterCard) that can be paid online. In the case of online payment, the application is automatically approved when the payment is received. The confirmation message will be sent to the e-mail address you wrote during registration.

6. APPLICATION PREFERENCE PROCEDURES

- 6.1.** Preference procedures will be made at <http://yosbasvuru.atauni.edu.tr/>.
- 6.2.** A total of 15 preferences are received from candidates, 5 preferences for formal education programs and 10 preferences for ATA-AÖF (Atatürk University Open and Distance Education Faculty) programs.

7. PLACEMENT PROCEDURES

- 7.1.** Main Placement Period: 2023-TR-YÖS/2, 2024-TR-YÖS/1, 2024-TR-YÖS/2, 2025-TR-YÖS/1 exam results can be applied.
- 7.2.** First Additional Placement Period: This is the period in which applications can be made with the results of 2023-TR-YÖS/2, 2024-TR-YÖS/1, 2024-TR-YÖS/2, 2025-TR-YÖS/1 exams. In this period, candidates who made a preference during the main placement period but could not be placed in any program and candidates who took the 2023-TR-YÖS/2, 2024-TR-YÖS/1, 2024-TR-YÖS/2, 2025-TR-YÖS/1 exams will be able to apply.
- 7.3** Second Additional Placement Period: 2023-TR-YÖS/2, 2024-TR-YÖS/1, 2024-TR-YÖS/2, 2025-TR-YÖS/1 exams or international exam results and diploma score (only for Open and Distance Education Faculty Programs and Associate Degree Programs -excluding Health Programs-) announced to be accepted by Atatürk

University. In this period, candidates who have made a preference in the main placement or the first additional placement period but could not be placed in any program, candidates who have taken the 2023-TR-YÖS/2, 2024-TR-YÖS/1, 2024-TR-YÖS/2, 2025-TR-YÖS/1 exams or candidates with international exam results and diploma points declared to be accepted by Atatürk University will be able to apply.

7.4. International exam results and diploma scores accepted by Atatürk University in additional placement applications will be evaluated by multiplying by 0.9. For the list of accepted international exams, [CLICK HERE](#).

7.5. The results of the applications and preferences made to the programs are announced to the candidates through the Student Information System.

8. REGISTRATION PROCEDURES

8.1 According to the results of the evaluation, students who have the right to enroll in the University must register with the necessary documents between the dates determined by the Registrar's Office on the official website. Candidates who do not register within the deadline are deemed to have lost their right to register. In order to register, the following documents must be provided:

For Those Residing Abroad:

- Original high school diploma
- Turkish translation of high school diploma certified by the Turkish Foreign Representative Office
- Diploma Equivalency Certificate (obtained from the Turkish Foreign Representative Offices in the relevant country)
- Placement Result Certificate
- 2 passport size photographs
- Passport and a copy of the passport translated into Turkish and certified by the Turkish Foreign Representative Office
- A written statement that they are financially capable of covering their expenses during their study period in our country (except for Turkish National students)
- Exam Result Certificate (except TR-YÖS Exam certificate)
- GCEAL exam result certificate for those who completed high school in TRNC
- Permission to renounce Turkish citizenship from the Ministry of Interior together with the blue card for blue card holders
- Civil Registration Certificate for dual nationals

For Those Have a Residence in Turkey:

- Original high school diploma
- Notarized Turkish translation of High School Diploma in Turkey
- Diploma Equivalency Certificate (obtained from Provincial Directorates of National Education)
- Placement Result Certificate
- 2 passport size photographs
- Passport and a copy of the passport translated into Turkish and certified by the Turkish Foreign Representative Office
- A written statement that they are financially capable of covering their expenses during their study period in our country (except for Turkish National students)
- Exam Result Certificate (except TR-YÖS Exam certificate)
- GCEAL exam result for those who completed high school in TRNC
- Permission to renounce Turkish citizenship from the Ministry of Interior together with the blue card for blue card holders
- Civil Registration Certificate for dual nationals.

8.2. Those who submit falsified, false, incomplete and inaccurate information and documents during the application, placement and registration process will have their registration canceled and legal proceedings will be initiated against them, even if their final registration has been made.

- 8.3.** Candidates who are eligible for final registration can only register for the programs they are entitled to register for.
- 8.4** The registrations of the candidates who prefer and place in the programs that take students with a special talent exam will be made if they take the Special Talent Exam to be held by the Faculty to which the program they are placed and if they are successful in this exam.
